IMPLEMENTATION OF EXECUTIVE ORDER – 03 "SUPPORT FOR LOCAL CONTENT IN PUBLIC PROCUREMENT BY MINISTRIES, DEPARTMENTS AND AGENCIES (MDAs) OF THE FEDERAL GOVERNMENT OF NIGERIA": LOCAL CONTENT SOLICITATION PROCEDURES AND DOCUMENTS

Further to the issuance of the Executive Order No. 003 of 2017 (EO-003, 2017) on the provision of Support for Local Content in Public Procurement by Ministries, Departments and Agencies (MDAs) of the Federal Government of Nigeria, all MDAs are therefore deemed to have commenced the implementation of the specific directives of the EO-003, 2017.

- 2. Accordingly, Ministries, Departments and Agencies (MDAs), in line with the stipulations of the Executive Order 03, are required to grant preference to local manufacturers of goods and service providers in their procurement of the goods and services covering the following areas, and with at least 40% of procurement spending:
 - Uniforms and Footwear;
 - 2. Food and Beverages;
 - 3. Motor Vehicles;
 - 4. Pharmaceuticals;
 - 5. Construction Materials:
 - 6. Information and Communication Technology;
 - 7. Furniture & Fittings;

- 8. Stationery; and
- 9. Information and Communication Technology.
- 3. In the realisation of the above, MDAs shall at the procurement planning stage identify procurement items in their procurement plan that will qualify for the application of local content preference. This shall be done in such a manner that the estimated procurement spending on each of the categories listed in paragraph 2 above will amount to 60% of the estimated total spending for each category in order to be able to meet the expected minimum actual spending of 40% at implementation stage.
- 4. Therefore, any MDA in its solicitation document for any of the identified local content procurement items, shall clearly indicate the preference to be granted to domestic manufacturers, contractors and service providers and the information required to establish the eligibility of a bid for such preference in line with this guideline and the Public Procurement Act (PPA), 2007.
- 5. To be eligible for this local content preference for the identified local content procurement items, prospective bidders must have complied with the following as at the time of making submissions in response to the solicitation document issued by the procuring entity:
 - (a) Be identified as domestic company/firm as defined in the Public Procurement Regulations for Goods, Works, and Services, i.e. a business or professional organization:
 - i. incorporated or otherwise organized in Nigeria;
 - ii. having its principal place of business located in Nigeria;
 - iii. having at least 50% of its equity held by nationals of Nigeria;
 - iv. not having its assets controlled by foreign national or organization incorporated or organized outside Nigerian; and
 - v. with more than 50% of persons who will perform services under the contract whether employed directly or by a subcontractor be nationals of Nigeria.

(b) Intend to provide:

(i) goods listed in paragraph 1 that possess Mandatory Conformity Assessment Programme (MANCAP) Certificate issued by the Standards Organisation of Nigeria (SON); and/or

(ii) services listed in paragraph 1 with possession of verifiable statement and sworn affidavit on the local content of services to be provided in compliance with 5(a) above.

- 6. In view of the above, MDAs shall include in the solicitation documents (advertisement, bidding documents, etc.) for the identified local content procurement items, the following additional criteria:
 - (a) documentary evidence to show that the bidder is a local company/firm;
 - (b) verifiable statement and sworn affidavit on the local content of services to be provided and
 - (c) photocopy of MANCAP Certificate for the proposed goods.
- 7. The criteria in paragraph 6 above shall be a pass or fail assessment and not to be subjected to scoring. Only the bidders that pass shall proceed to the financial evaluation stage of the procurement process.
- 8. Compliance with declared goods or services by bidder shall be subjected to confirmation by MDAs before award during post-qualification exercise and at delivery during contract implementation.
- 9. In implementing the provisions of the EO-03, all stakeholders shall ensure compliance with the Responsibility and Reporting Framework presented below:

- 10. If any MDA encounters any challenge in implementing this provision of EO-03 either in the course of procurement process or at implementation stage, such should be communicated to the Bureau of Public Procurement and copy the Federal Ministry of Industry, Trade and Investment (FMITI) Local Content Unit.
- 11. In performance of its oversight of the implementation of the EO-03, the FMITI Local Content Unit and Standards Organisation of Nigeria (SON) shall carry out periodic audits and inspections to incountry manufacturers for the purpose of verifying and utilizing incountry manufacturing capabilities.
- 12. All MDAs should immediately commence the implementation of the EO-03 in all their procurement activities, covering the specified item categories indicated in paragraph 2, while ensuring compliance with this guideline and the Public Procurement Act, 2007.
- 13. Please ensure strict compliance with the contents of this circular.
